## **Opportunity Summary**

IntraBio is developing the novel drug N-acetyl-L-leucine (IB1001) for Niemann-Pick disease Type C (NPC). The New Drug Application (NDA) has been submitted to the US Food & Drug Administration (FDA).

The insights of parents, caregivers, and patients have been invaluable throughout the IB1001 development program. As we progress towards potential approval and commercialization, we deeply value the insights of parents, caregivers, and patients.

IntraBio is establishing a Patient & Caregiver Advisory Meeting specifically for **parents and caregivers** of living NPC patients aged 4 years or older or **adult patients** affected by NPC. Your valuable feedback will guide us through this pivotal stage, ensuring that patient and family perspectives remain central as we prepare for potential approval and commercialization.

You will be asked to participate in a single two-hour virtual meeting, bringing your NPC experience and ensuring that the patient voice and experience remains central to our planning.

Time Commitment: One 2-hour meeting via Zoom (potential for additional meetings)

**Paid Expenses:** \$150 per hour for attendance and participation in the IntraBio Patient Advisory meeting (\$300 honorarium for 2 hour meeting)

### Who is eligible?

- NPC patients age 18 and older
- Parents of living NPC patients age 4 years and older
- Spouses of NPC patients
- U.S. residents only
- Eligible participants may have previous or current experience on an experimental therapy for NPC. Previous clinical trial or expanded access program participation, or a research background is not a requirement.

### If selected to participate, you will be required to...

- Attend and take an active part in one IntraBio Patient & Caregiver Advisory Meeting on your agreed upon date for the entirety of the session.
- Log in to the meeting on a computer with a working camera and microphone, without background interference. Please do not log in on a mobile device.
- Provide a brief written background on your family experience with NPC including any participation in clinical trials or compassionate use programs in advance of the meeting.
- ► Share your unique NPC perspective to provide guidance on the patient and family experience.
- ▶ Provide critical and constructive feedback to guide IntraBio as we prepare for commercialization.
